Section 4: First aid measures

4.1 Description of first aid measures

Skin contact: take off contaminated clothes immediately. Wash contaminated skin with a large amount of water. Contact a doctor if disturbing symptoms occur.

Eye contact: protect non-irritated eye, remove contact lenses. Rinse contaminated eyes thoroughly with water for at 10-15 minutes. Avoid strong stream of water – risk of damage of the cornea. Contact an ophthalmologist if disturbing symptoms occur.

Inhalation: remove the victim to fresh air. Keep warm and calm. Contact a doctor if disturbing symptoms occur.

4.2 Most important symptoms and effects, both acute and delayed

Skin contact: possible redness, burning sensation, irritation, allergic reaction.

Eye contact: possible tearing, burning sensation, pain, irritation.

Ingestion: may cause gastrointestinal problems.

Inhalation: may cause irritation of respiratory tract.

4.3 Indication of any immediate medical attention and special treatment needed

Section 5: Firefighting measures

5.1 Extinguishing media

8.2 Exposure controls

Appropriate engineering controls
